

Research

Campaign Funds for Childcare (CFCC)

In 2024, Vote Mama Foundation launched two groundbreaking reports that highlight the challenges and opportunities for moms in politics. At the start of the year, we released a report on Campaign Funds for Childcare that explored its usage, access, and impact, showing a **662 percent** increase in funds spent by federal candidates and a **2,156 percent** increase for state and local candidates since 2018. As the only organization tracking CFCC and fighting to authorize its use in every state, we will continue to push to approve CFCC in all 50 states in 2025 and beyond.






Politics of Parenthood (POP)

This year, we published our third <u>Politics of Parenthood</u> report focusing on the <u>representation of mothers with</u> <u>minor children serving in state legislatures</u> in 2024, examining the barriers they face and providing first-of-its-kind data on attrition.

The report revealed that **7.9 percent** of all 2024 state legislators are mothers with minor children, equating to a nearly **49 percent** increase in representation since Vote Mama Foundation first collected this data in 2022.

Our research underscores the challenges moms face when serving in public office and the solutions needed to ensure their leadership is fully represented.




Policy

Campaign Funds for Childcare (CFCC)

In 2024, <u>Campaign Funds for Childcare (CFCC)</u> was approved in eight new states, plus Washington, D.C. Overall, 29 CFCC bills in 17 states were introduced to codify CFCC into state statutes. Our team also helped submit five ethics ruling requests in Hawai'i, Indiana, Oklahoma, Pennsylvania, and Washington, D.C.; two Secretary of State Opinion requests in Idaho and Michigan; and one Attorney General Opinion request in Arizona.

<u>CFCC</u> has now been approved in more than 75 percent of the country (39 states plus Washington, D.C.), a monumental victory for Vote Mama Foundation. We are energized and laser-focused on getting CFCC authorized in all 50 states.

Campaign Funds for Security (CFS)

Our playbook for securing CFCC has a proven track record of success, earning bipartisan support and authorization from West Virginia to California. Data shows that CFCC is one of the most effective ways to increase the representation of families from all walks of life in politics.

Now, we're building on that success to advocate for <u>Campaign Funds for Security (CFS)</u>. No parent should have to worry about their safety—or their child's safety—while running for office. Our approach can be seamlessly replicated to ensure that candidates have the resources they need to protect themselves and their families, making it possible for more parents to step up and lead.

Politics of Parenthood Report Launch

In September, Vote Mama Foundation and The Century Foundation convened at the Library of Congress for a joint launch of Vote Mama Foundation's 2024 POP report and professor Jessica Calarco's new book, Holding It Together: How Women Became America's Safety Net. The event featured remarks from a dynamic group of leaders committed to advancing equity and family-friendly policies. U.S. Rep. Jennifer McClellan (VA-04) highlighted the importance of having moms in office, professor Jessica Calarco shared insights from her book on America's safety net and how women are impacted, and Vote Mama Foundation founder and CEO Liuba Grechen Shirley emphasized the work Vote Mama Foundation is doing to break the structural barriers moms face when running for and serving in office. Julie Kashen, senior fellow and director for women's economic justice at The Century Foundation, and Victoria Pelletier, Portland city councilor and national partnerships manager at RepresentWomen, reinforced the need to make our government more accessible through collaborative action to build a more equitable future.

Staff Retreat

This year, Vote Mama Foundation hosted its first-ever staff retreat in Chicago, bringing together our dedicated team from across the country to strategize, connect, and strengthen our shared vision. We reflected on our incredible progress, set bold goals for the future, and deepened the relationships that make our work possible.
